### Updated VA/DOD PTSD Guidelines and Recommendations Released: Learn About the Changes http://bit.ly/2tDIXJS

The Department of Veterans Affairs (VA) and Department of Defense (DoD) released an updated version of the <u>VA/DoD Clinical Practice Guideline (CPG)</u> for the <u>Management of Posttraumatic Stress Disorder (PTSD)</u> and <u>Acute Stress Disorder (ASD)</u>(link is external).

The new version incorporates research conducted since the last revision in 2010 and covers treatment for both PTSD and ASD. There are several new recommendations, so both seasoned and new mental health practitioners should take time to review it.

CLEVELAND, OH (WOIO) - Fisher House Foundation to build two homes in Northeast Ohio The VA will begin working with the <u>Fisher House Foundation</u> to construct not one, but two Fisher Homes in Northeast Ohio.

The Fisher House Foundation is known for their network of comfort homes built near the grounds of major military medical centers. The home provides a place for veterans' families to stay while their loved ones receive treatment.

Located adjacent to the grounds of The Louis Strokes VA Medical Center in University Circle, the homes will have twelve to fourteen suites and accommodate up to 50 family members.

The construction of the homes was made possible by a land transfer from the Cuyahoga Land Bank, as well as over \$3 million in donations from the Northeast Ohio community over the last four years.

The NACo Annual Conference & Exposition is the only meeting that draws a cross section of elected officials and county staff from across the country.

Attendees from rural and urban counties, large and small budgets and staff – all come together for four days of education, networking and sessions aimed to help improve residents' lives and the efficiency of county government.



The National Association of Counties (NACo), the Council of State Governments (CSG) Justice Center, and the American Psychiatric Association (APA) Foundation have come together to lead a national initiative to help advance counties' efforts to reduce the number of adults with mental illnesses and co-occurring substance use disorders in jails.

With support from the U.S. Justice Department's Bureau of Justice Assistance and other sponsors, the initiative will build on the many innovative and proven practices being implemented across the country.

### Stepping Up Summit Part One: Identifying People with Mental Illnesses in Your Jail July 23rd

More than 350 counties have passed a resolution to join Stepping Up: A National Initiative to Reduce the Number of People with Mental Illnesses in Jails. To support counties in their efforts, NACo is hosting a two-part Stepping Up Summit to provide counties with the tools and resources they need to further their initiatives.

Part One will focus on providing an overview of strategies counties are using to identify people with mental illnesses in their jails and how they are using this information to inform policies, practices and funding allocations. All counties are welcome to attend the summit.

Stepping Up Summit Part Two: Implementing Policies and Programs to Reduce the Number of People with Mental Illnesses in Your Jail *July* 23<sup>rd</sup>

More than 350 counties have passed a resolution to join Stepping Up: A National Initiative to Reduce the Number of People with Mental Illnesses in Jails.

To support counties in their efforts, NACo is hosting a two-part Stepping Up Summit to provide counties with the tools and resources they need to further their initiatives.

Part Two will highlight policies, practices and programs that counties have implemented along four key measures: the number of people with mental illnesses booked into their jail, the length of stay of people with mental illnesses, connections to treatment and recidivism. All counties are welcome to attend the summit.

# **BJS:** Research: Indicators Of Mental Health Problems Reported By Prisoners And Jail Inmates, 2011-2012 http://bit.ly/2tDlpDr

Presents prevalence estimates of mental health indicators among state and federal prisoners and jail inmates by different time periods, demographics, criminal justice history, most serious offense, mental health treatment received while incarcerated, and rule

violations. Indicators were defined as serious psychological distress (SPD) in the 30 days prior to the interview or having a history of a mental health problem. Data are from BJS's 2011-2012 National Inmate Survey. Comparisons to the general population are based on data from the Substance Abuse and Mental Health Services Administration's National Survey on Drug Use and Health, conducted in 2009, 2010, 2011, and 2012.

#### Highlights:

- More jail inmates (26%) than prisoners (14%) met the threshold for serious psychological distress (SPD) in the past 30 days.
- Among those who had ever been told they had a mental disorder, the largest percentage of prisoners (24%) and jail inmates (31%) reported they had a major depressive disorder.
- More prisoners (14%) and jail inmates (26%) met the threshold for SPD in the past 30 days than the standardized general population (5%).
- Prescription medication was the most common treatment type for prisoners and jail inmates who met the threshold for SPD in the past 30 days.
- Fourteen percent of prisoners and 10% of jail inmates who met the threshold for SPD in the past 30 days were written up or charged with assault.

# **DOJ Research:** Majority of U.S. Inmates Don't Get Mental-Health Treatment, Study Finds http://thebea.st/2tEprvp

People in jail and prison are 5 times more likely to have a mental-health problem than the general population, the Justice Department reports.

Most aren't getting what they need.

Only one-third of inmates in the U.S. with mental-health problems receive treatment, according to a new Department of Justice report released Thursday. In federal prisons, about half of those who need treatment get it, DOJ found.

Inmates are five times as likely to have a mental-health problem than the general U.S. population.

The report, by Jennifer Bronson and Marcus Berzofsky, found most prisoners and jail inmates with a mental-health problem have at some point received treatment in their lives. Overall, more jail inmates have a current mental health problem than federal prisoners.

A higher percentage of women meet one or both of the criteria: 20 percent of female federal prisoners 32 percent of female jail inmates. Whites were found to have reported a mental health problem more often than black and Hispanic inmates and prisoners.

# CA: San Francisco Mayor Lee proposes \$27M package of diversion programs to help reduce jail population <a href="http://bit.ly/2tDWKyY">http://bit.ly/2tDWKyY</a>

San Francisco leaders are attempting to further reduce recidivism in a city already replete with programs targeting people who repeatedly cycle in and out of jail and the criminal justice system.

The effort adds on to existing programs that are meant to help stop the cycle of poverty, drug abuse and generational incarceration that plagues many of the people stuck in San Francisco's criminal justice system.

The latest plan to slow recidivism comes in the form of a \$27 million budget proposal, which has been public for weeks, but was touted Thursday by Mayor Ed Lee as a new package of funds for diversion.

The not-yet-passed budget proposal would also be aimed at improving services for people with drug abuse issues and mental health problems.

### GA: Dougherty County mental health court to expand <a href="http://bit.ly/2sUJ7hG">http://bit.ly/2sUJ7hG</a>

DOUGHERTY CO., GA (WALB) - Dougherty County's nationally recognized mental health court is expanding to offer a service to help non-violent, first offenders stay on track.

Dougherty Superior Court Judge Steve Goss requested close to \$24,000 to pay for two part-time positions for the circuit's mental health and substance abuse program.

Goss said the program has resulted in lowered recidivism and fewer people in the jails.

The two POST certified deputies will provide random check-ins for first offenders who are not on state probation, providing a level of supervision the county has never had before.

"Because of that, they are not on state probation, hence, we don't have the capacity to supervise them with probation officers like many of our participants are.

So this would just add a level of supervision and accountability in the community with law enforcement," said Goss.

The money will come from the Drug Abuse Treatment and Education state fund given to the county for specific services like counseling.

The Cobb County Board of Commissioners recently accepted grants by the Criminal Justice Coordinating Council totaling almost \$1.32 million to fund programs through June 30, 2018:

• \$201,278 for the Mental Health Court, supporting the coordinator and judicial program coordinator positions with a local match of \$22,364 required.

CELINA – Leaders from throughout Mercer County met Thursday to determine how to help residents with mental illness issues.

The meeting was on a two-day Stepping Up Initiative conference on Sequential Intercept Mapping aimed at keeping people from slipping through the cracks of the legal system and anticipating what services such people might need.

# VT: responders first in U.S. to gain workers' comp for mental health - The historic legislation could pave the way for responders all over the country <a href="http://bit.ly/2sDIPHQ">http://bit.ly/2sDIPHQ</a> BURLINGTON, Vt. — Vermont responders will now be the first state in the U.S. to receive workers' compensation for mental health issues.

VTDigger reported that the Professional Firefighters of Vermont and the Vermont Troopers Association said the extreme conditions in which they work take a toll on not only the body, but the mind as well.

Our members will be able to access treatment that will keep our firefighters and paramedics on the street, and keep them healthy so they can continue to provide the essential emergency services Vermonters call for every day," Professional Firefighters of Vermont president Bradley Reed said.

The bill overturns a Vermont Supreme Court ruling that prohibits responders from receiving workers' compensation for mental health issues such as post-traumatic stress disorder. Prior to the bill, workers' compensation was only allowed for mental health if it was related to a physical injury.

WASHINGTON, June 28, 2017 — The American Bar Association, ARAG® legal insurance and CuroLegal today announced the launch of a new online tool, Legal Checkup for Veterans. The free web-based application helps veterans identify legal needs in their lives – and provides them with straightforward suggestions and resources to help resolve their legal issues.

The online tool is part of a signature initiative by ABA President Linda Klein to improve legal services for veterans, and will complement other resources being developed by the ABA Veterans Legal Services Commission.

"Legal Checkup for Veterans is a much-needed tool that offers a necessary first step in solving this important group's access to justice issues," Klein said. "It provides veterans with free and fast help in identifying their legal needs and clear paths to resolution."

It also provides veterans with useful advice about what they can expect when reaching out to resources for resolution – including documents they will need to resolve their problem and sample questions they should be prepared to ask.

### MT: Tester announces resources to help Montana veterans recover from addiction - Senator Announces \$325,000 for Great Falls Veterans Court http://bit.ly/2tDO0st

BIG SANDY — U.S. Senator Jon Tester today announced \$325,000 to expand the Veterans Treatment Courts in Great Falls and enhance services for its participants. Veterans Treatment Courts provide an alternative to the traditional criminal justice system for former service members struggling with addiction, helping them address the underlying causes of their addiction and putting them on a path to recovery instead.

"Our service men and women risk everything to protect the people of this country and often endure mental and physical trauma as a result," Tester said. "We owe our veterans a chance at redemption and recovery, and that's exactly what Veterans Treatment Courts do. These courts have a proven track record of making a real difference in the lives of many men and women who served."

The funding comes from the Substance Abuse and Mental Health Services Administration and will go towards expanding the capacity of the Great Falls Veterans Treatment Court to provide even more veterans with recovery support and care.

Established in November of 2013 by Great Falls District Judge Gregory Pinski, the Great Falls Veterans Treatment Court requires participates to attend hundreds of meetings and treatments sessions with legal and health professionals over an 18 month period.

The program celebrated its first graduating class in March of 2015. Nationally, studies show that 75 percent of veterans successfully complete the program and among those successful graduates, 70 percent do not reoffend over the next two years.

#### NH: Gov. Sununu Signs Veterans Court Bill into Law http://bit.ly/2sGDNOF

Governor Chris Sununu has signed legislation to establish uniform guidelines for the state's veterans courts.

Veterans courts give some vets grappling with mental health or drug use problems a chance to solve them without going to jail. These courts already exist in Nashua, Manchester, and the Upper Valley.

The law spells out ten key components for them. Those components include monitoring of veterans in the program and the integration of alcohol, drug, and mental health services.

Under the legislation, veterans who complete the treatment programs spelled out by the court can, after at least one year, petition for the annulment of the charges or conviction that put them in the court.

The law takes effect in 2018.

# NY: New Traffic Court Tries to Keep Veterans on the Road of Return (NYT Feature Story) <a href="http://nyti.ms/2tDnQpL">http://nyti.ms/2tDnQpL</a>

Last year, a survey released by the United States <u>Department of Veteran Affairs</u> found that, among former service members who were homeless or at risk, help restoring driver's licenses and resolving outstanding warrants and fines ranked as one of the highest unmet needs.

Suffolk County has the largest veteran population in New York State and one of the largest in the country. At the Touro Law Center Veterans' and Servicemembers' Rights Clinic on Long Island, veterans were often looking for help with traffic citations they could not afford to pay, said Ken Rosenblum, the clinic's retired director. One veteran, he said, had \$9,000 in unpaid fines.

For a struggling veteran, losing the ability to drive legally had the potential to snowball into a devastating chain of events. "It's a one-way ticket to homelessness," Mr. Rosenblum said. "If you don't have a driver's license on Long Island, you can't get to work. You can't get to medical treatment."

- ... Veterans advocates on Long Island encouraged officials here to create a court program exclusively handling the traffic cases of former service members after finding that Mr. Rodriguez's situation was far from unique, and reflected a widespread problem among former service members.
- ... Steve Bellone, the Suffolk County executive, who served in the United States Army, said the traffic court for veterans shows the county's responsibility "to make sure when they return home, we're doing everything we can to assist their transition back to civilian life."

Advocates praised the program as "forward thinking," stepping in to provide help before a problem spirals further downward.

#### UK: Police force will offer veterans help http://bbc.in/2tDQdUK

A new service aimed at reducing the number of crimes committed by veterans has been launched by Thames Valley Police.

It will see anyone with armed forces links who comes into contact with officers through welfare or criminal incidents given access to support.

**A government report in 2014** estimated 3-7% of prisoners in England and Wales had military backgrounds.

Thames Valley will be working alongside military charity SSAFA.

A police spokesperson said other forces will also adopt the service in future.

Both <u>Nottingham Police</u> and <u>Kent Police</u> have piloted similar projects but Thames Valley said its scheme will have the first "established referral mechanism".

Julie McCarthy from SSAFA said she hoped the project would help with the rehabilitation of veterans and lower re-offending rates.

PC Anthony Colton, from Thames Valley Police, said the project was about providing "better support" for the armed forces community.

Caring for a wounded warrior takes an emotional toll on their caregivers.

RAND's "Hidden Heroes: America's Military Caregivers' Report" reported on the statistical data of mental illness among military caregivers. However, there is no report which

specifically focuses on the darker side of military caregiving — suicidal thoughts, self-harm and in the worst cases, suicide itself.

According to RAND, 38 percent of post-9/11 military caregivers, and 19 percent of pre-9/11 military caregivers have Major Depressive Disorder (MDD). Many of the post-9/11 caregivers who suffer from MDD are female, younger, of lower-education and income levels, and usually have at least one minor child.

I've seen this depression on the faces of my military caregiver friends, and I have felt it. When the service member or veteran is in need of medical care, the caregiver ignores their own well-being — sometimes depression, sometimes to the brink of death and sometimes martyrdom.

How can a military caregiver slip into depression? From what I've witnessed, it does not happen overnight, instead it is a slow buildup of multiple factors from geographic location to lack of community support.

### Research study suggests possible ties between low cholesterol levels and suicide risk in Vets <a href="http://bit.ly/2sGwyqd">http://bit.ly/2sGwyqd</a>

. . . Reuter's <u>database study</u>, published in April 2017 in *Research in Nursing & Health*, finds that Veterans with total cholesterol levels below 168 mg/dl (milligrams per decileter) appear to be at higher suicide risk than those with higher levels. That figure is approximately 25 to 30 mg/dl lower than what cardiology groups consider a desirable cholesterol level for adults. High cholesterol levels may put one at risk for heart disease, heart attack, or stroke.

In addition, according to the study, cholesterol levels in Veterans reporting suicide ideation, or thoughts of committing suicide, and suicide attempts were much lower than the group reporting neither. Plus, there was a notable increase in suicidality with as little as a 20 percent reduction in a Veteran's normal cholesterol level.

COURT HOUSE – As part of its efforts to better serve area veterans, Atlantic Cape Community College has opened a new lounge and will offer TeleHealth services at the Cape May County Campus, 341 Court House-South Dennis Road, Court House.

The veterans lounge will serve as a meeting place for current Atlantic Cape veteran students to convene, relax and get to know one another. In the lounge, there are couches, a computer and internet access, relevant veteran community resources and television, according to a release.

The veterans lounge at the Cape May County Campus is the first of the college's three lounges. Spaces are identified for similar lounges at the Atlantic City Campus and in the Student Center under construction at the Mays Landing Campus.

The college will also provide veterans with the ability to connect to health providers to address any health-related matters virtually through TeleHealth in the future.

# University of Southern California (USC) Research: The possible long-term complications of traumatic brain injury <a href="http://bit.ly/2sGPTHN">http://bit.ly/2sGPTHN</a>

USC researcher uses sophisticated techniques to understand the effects of such injuries among older adults

After a traumatic brain injury, when do the first indications of possible long-term complications — including dementia — appear and is it possible to stave them off?

A five-year R01 grant from the National Institute of Neurological Disorders and Stroke totaling more than \$1.5 million will support one facet of brain injury research through 2021. The project will examine the effects and prognoses of small bleeds, or microhemorrhages, in the brain following traumatic brain injury in older adults.

"We want to understand whether these microhemorrhages are benign or whether they can cause serious problems for patients down the line," said Andrei Irimia, an assistant professor at the USC Leonard Davis School of Gerontology who uses sophisticated neuroimaging techniques to understand the effects of brain injuries and improve the quality of life of sufferers, especially older adults.

Only 2 percent of R01 grants go to researchers under the age of 35. Irimia said the grant reflects not only the increase in attention paid to the topic of brain injury itself but also the National Institute of Health's interest in supporting precision medicine research; traumatic brain injury is a challenge that demands a personalized approach, he noted.

"No two TBIs are the same — they vary from patient to patient," he said. "It's difficult to study at the population level."

Congress created the U.S. Court of Appeals for Veterans Claims in 1988 to hear appeals from the U.S. Department of Veterans Affairs.
